Membership is limited to individuals who:

- Have a CFA registered cattery name;
- Are at least 18 years of age or older;
- Have bred and registered with CFA at least three litters of the appropriate breed/division. A litter which has been reregistered to add an individual(s) as an additional breeder(s) of the litter

may not be used to qualify the additional breeder(s).  
• Are not a judge or an officer of another cat registering association.

**And, in addition, have either:** Bred at least one CFA Grand Champion or Grand Premier of the appropriate breed/division; **OR** registered one

litter of the appropriate breed/division within the previous two calendar years, since May 1, 2017; **AND** Exhibited a cat/kitten owned or leased by the applicant of the appropriate breed/division at a CFA show within the previous two calendar years, since May 1, 2017.

CFA Breed Council members can reduce the amount of duplicate and/or unwanted items received in their household by selecting Option A or B. A regular membership packet includes a show standard for every CFA breed and the CFA Show Rules. A member can choose to NOT

receive the complete set of standards (option A) or to NOT receive the Show Rules & the Show Standards (option B). Please check the appropriate box if any of the materials listed are redundant or unwanted. If neither box is checked, you will receive the Show Rules & Show Standards.

**Option A**  Do **NOT** send the Standards for EVERY breed (you will receive the standard for the individual breed(s) you are joining).

**Option B**  Do **NOT** send the Show Rules or Show Standards.

**IMPORTANT:** Current members aren't required to provide the general information listed above (e.g. cattery name, three litters, etc.) therefore a space is not provided. **HOWEVER**, it is still necessary for current members renewing their membership to complete the items below, #1 (if you now can qualify for the breed council by having bred a Grand) **OR** 2a, 2b **AND** 2c (the alternative method of qualifying for breed council).

**\*\*\* APPLICANT must complete EITHER items 1 and 3 OR 2a, 2b, 2c and 3. Incomplete applications will be returned unprocessed. \*\*\***
