<u>SUSPENSION OF ALL CFA SERVICES</u> means that the person suspended will be prohibited from participating in any CFA activity including, but not limited to:

- i. Utilizing CFA's registry services
- ii. Acting in any capacity at a show
- iii. Entering cats owned by the suspended person, agenting cats, or having cats owned by the person suspended agented at a CFA show
- iv. Presenting cats in a show ring
- v. Participating in a clerking school
- vi. Participating in a Breed Council
- vii. Acting as a delegate at an Annual Meeting

The suspended person will be permitted to purchase the *CFA Yearbook*, *Cat Talk* and other CFA publications. However, the person suspended will not be permitted to advertise in any CFA publication or show catalog.

A person who is suspended may remain a member of a CFA member club. They may also attend their Region's annual banquet and award ceremony provided that they do not officiate or make any presentation at the banquet or award ceremony.
