Per CFA Rules, your check must accompany entries or payment must be made within 10 days of on-line entry or the start of the show, whichever comes first; no post-dated checks or phone entries. There will be no refunds or waived fees for failure to bench.

The Expo Center concession will have people food for sale. Our contract with them specifically prohibits bringing in food from outside. Please help us protect our show hall by not bringing coolers inside.

Cats of Wisconsin Cat Club will follow all applicable COVID-19 and related health and safety mandates, restrictions and guidelines in the production of this show. CFA best practices for clubs and participants will also be followed. Spectators will be admitted in accordance with the facility's policies.

All entries must be registered with CFA (or have a TRN number), except kittens and household pets. All Championship, Premiership and registered Kittens and Household Pets will be CFA scored. Registration numbers must be printed in the catalog or provided to the Master Clerk. No kitten under 4 months of age will be allowed in the show hall; exhibitors must have litter registration available to verify kitten's age. Only 2 cats or 4 kittens allowed per double sales cage.

Show hall is air conditioned, heated and is handicapped accessible. Handicapped benching requests will be accommodated, at no additional charge to the exhibitor. Free parking available.

In accordance with Wisconsin State statutes and CFA rules, there will be NO SMOKING in the show hall.

All cats must be free from fleas, ear mites or any infectious or contagious illness. You are strongly advised to have your cat inoculated by a licensed veterinarian against panleukopenia, feline rhinotracheitis, calici viruses and rabies and tested for feline leukemia virus before entry. Front and rear claws must be clipped prior to benching. No declawed cats may be entered. This show is conducted under the current CFA rules. Rules are available for \$7 from CFA Central Office, 260 East Main Street, Alliance, OH 44601. Booth Space: Booth rates are \$75 for a single (12' wide x 8' deep) space and \$125 for a double (24' wide x 8' deep) space. Each space includes 1 table; additional tables available for \$10 each. Contact JoAnn Brubacher, 715-302-5868, luvnmittens@aol.com

Supplies: Litter will be furnished. Please bring your own litter pan; also your own cat food, water and food dishes.

Cages: Approximate cage space is 21" x 21" x 21" (single cage space included with entry). Second entry by same owner will be benched in the other half of a security cage, or the other half benching space may be purchased for extra \$20. Single entries with any size security cage require the purchase of an extra half cage space. Single security cage spaces are NOT available.

Bring your cat to the show hall in a carrier or other sturdy container. You will need drapes or towels to hang on the inside and to cover the top and the bottom of the cage. Reasonable care will be taken of all cats and personal property, however, the show management is not responsible for anything lost or damaged.

Airport: MKE – Milwaukee, Wisconsin

Hotels: Be aware that most hotels in the area do not allow cats, even if they are listed as pet friendly. The Best Western close to the show hall no longer will make an exception. We have a block of rooms at the La Quinta in New Berlin (14 miles east from show hall). Our group rate is \$119 for king or double queen room with no pet fee. You can either call them or book online using group name CGCATS. The block will be held until March 15. 15300 W Rock Ridge Rd, New Berlin, 262-717-0900. The La Quinta in Delafield will not allow cats.

The only other suggestion is Comfort Inn, 2510 Plaza Court, Waukesha, 262-786-6015. This is 4.2 miles from the show hall. You can book online using whatever discount codes you have. Currently the price with AAA or AARP is \$99. Be aware they have a pet fee of \$20 per pet, per night, that they are very strict about.
