Current CFA COVID-19 Info: This show is inviting spectators **FOR THE WELL-BEING OF CLUBS & PARTICIPANTS CFA COVID-19 requirements & CFA recommended COVID-19 general practices will be in effect.** www.cfa.org/covid-requirements All federal, state and CFA mandatory COVID-19 restrictions will be observed. All attendees are expected to follow the CFA mandatory COVID-19 requirements and recommended general practices, local, county, state, national and event facility regulations. **Regulations and guidelines are subject to change and will be communicated separately.**

Entry & Payment Info: Entries are accepted now. You must enter each show separately. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Coastal Paws Cat Club. **All payments at check-in must be CASH only.** No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.**

Show Hall: The show will be held in the Holshouser Building on the NC State Fairgrounds, 4285 Trinity Rd. Raleigh, NC 27607 PH: 919-821-7400. The building is heated and handicapped accessible. There is no smoking in the show hall.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Check in & Show Hours: Saturday Check in: 8 – 9:30 am; judging will begin at 10am. Sunday check-in 7:30-8:15 am; judging will begin at 8:30 am. Cats not benched by end of check in will be marked absent. Advertised show hours 10 am – 4 pm on Saturday & 8:30 am – 3 pm on Sunday.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Benching: Single cage size is approximately 22"x22"x22" and is included with your entry. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage. Litter will be provided, litter pans will not be furnished. Cats cannot be left in the show hall overnight.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Airport Info: Raleigh - Durham International Airport (RDU) is about 11 miles/15 minutes from the show hall.

Show Rules: CFA Show rules will be strictly enforced. A copy of the current show rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601.

Liability: No watchman will be provided during non-show hours. Coastal Paws Cat Club will take reasonable care to safeguard the personal property of exhibitors; however, neither the club, its members nor the NC State Fairgrounds will be liable for any loss, damage or injury to exhibitors or to their cats.
