## CAT COSTUME CONTEST Prizes for Top 3

All entries are expected to remain in the show hall until the advertised closing time. Early departure without permission of the show manager may cause all awards won to be voided, except as otherwise provided in the CFA Show Rules.

**SHOW HALL:** Lamar-Dixon Expo Center is handicapped accessible and is heated & air conditioned. Smoking is not permitted in the show hall. The Expo Center will have a concession stand. Grand parties are welcome.

**HEALTH INFORMATION: THIS IS A NON-VETTED SHOW.** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Only cats which appear healthy, without evidence of fleas, ear mites, or any contagious or infectious illness, are eligible for admission into the show room. All claws must be clipped prior to benching. Declawed cats are not eligible for entry. No kittens under the age of 4 months will be permitted in the show hall.

**ENTRY AND PAYMENTS:** All fees must accompany the entry. No entry fee will be refunded for failure to bench. Note: Double security cages with 1 entry require the purchase of an "extra 1/2 space".

**SCORING and AWARDS:** This show is licensed by The Cat Fanciers' Association, Inc. (CFA), and show rules will be strictly enforced. These rules may be purchased for \$7 plus S/H from The Cat Fanciers' Association, Inc., 260 East Main Street, Alliance, Ohio 44601, or downloaded at [www.cfa.org](http://www.cfa.org). All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards.

**HOTELS:** There is no specified show hotel. There are many hotels in/near the area of the show hall

**\*BENCHING CAGES AND SUPPLIES:** Exhibitors are responsible for providing their own benching cages/enclosures. A standard single benching cage is 22" x 22" x 22"; a double benching cage is 22" x 45" x 22". We have a very limited number of double wire benching cages available for use by exhibitors in the benching area. Please reserve the wire cage at the time you enter the show in the "Other Requests" section on the Entry Form. Use of a double wire cage for a single entry requires payment of an "extra 1/2 space" fee. Please see a Show Manager to pick-up the reserved cage. Bring cage curtains to cover the cage sides, back and top. Bring your own litter pans, cat food dishes and water dishes. Litter is provided. Greater Baton Rouge Cat Club & Lamar-Dixon Expo Center are NOT liable for any loss/damage of personal property.

Spectators will be present. For the convenience of our exhibitors, masks and hand sanitizer will be available. All city, parish, state, and federal Covid-19 and related health and safety mandates, restrictions and guidelines in the planning and production of this show will be followed. CFA Best Practices for clubs and participants will be followed.
