**ENTRY INFO:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. Fees must accompany entries and no fees will be refunded due to failure to bench. No postdated checks will be accepted. There will be a \$35.00 fee charged on all returned checks. Kittens must be four months of age or older on the opening day of the show.

**ENTRY FEES:** Make checks payable to: *Grand Canyon Cat Club*. First entry fee includes show catalog. Fees may also be remitted via Venmo to [socalcfaclerk@yahoo.com](mailto:socalcfaclerk@yahoo.com) but **please identify exhibitor name** in order to be credited properly. **NO PAYMENTS AT CHECK IN.**

**CLOSING DATE: Sunday, July 3, 2022, OR WHEN 175 LIMIT IS REACHED.**

**HEALTH:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition.

**AMENITIES:** Litter will be provided. Please bring your own benching cage, litter trays, food, and dishes. No more than one cat or two kittens may be benched in the same cage.

**AWARDS:** Ribbons and rosettes will be awarded in accordance with CFA show rules. Permanent flats will be used with satin flats available upon request. For a copy of the current CFA show rules, send \$7.00 to the Cat Fancier's Association, 260 E Main St., Alliance, OH 44601, or go to <https://cfa.org/wp-content/uploads/2022/03/22-23show-rules.pdf>. The club reserves the right to add judges not named to judge non-championship, Household Pet and veteran classes.

**SHOW HOURS:** Saturday check-in from 7:45 a.m. to 8:30 a.m. **Judging begins promptly at 9:00 AM on Saturday and 8:30 AM on Sunday.** Advertised show hours are 9:00 a.m.-5:00 p.m. Sunday hours are from 8:30 a.m. to 3:00 p.m.

**PEOPLE FOOD:** NO GRAND PARTIES or displays of food. Violators will be immediately evicted from the premises by facility personnel. There will be **FOOD AND BEVERAGES AVAILABLE FOR SALE.**

**HOUSEHOLD PET INFO:** Household pets 8 months of age or older must be spayed or neutered. ALL nails must be clipped and cats should be bathed. Contact the show manager if this is your first show and you have questions. **VETERANS:** Must be registered and at least 7 years old to be entered in this class.

**SHOW HALL INFO:** Rancho Santa Susana Community Center. Show hall is air conditioned and has ample parking. Smoking is not permitted in the show hall. Simi Valley is off the 118 freeway, so take your preferred freeway to the 118 and exit at Stearns. From the east, turn left on Stearns. From the west, turn right on Stearns. Go about 1 mile to Los Angeles Ave. and turn right. The hall will be on your right side.

**HOTEL:** No group rate available, but the closest hotel is the Extended Stay, located on Stearns. Also check Thousand Oaks, Moorpark, and Burbank for pet-friendly hotels as they will be less expensive than the Simi Valley area.
