Show Rules:

This is a CFA licensed show and all CFA show rules will be enforced. A copy of the show rules may be purchased from CFA. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. The Region reserves the right to add or substitute judges not named in the show flier should it become necessary.

COVID-19 Policy:

All attendees (club members, show committee, officials, participants, vendors, and spectators) are required to follow "CFA Mandatory COVID-19 Requirements"; local, county, state, national regulations; and event facility regulations that apply to the area for their type of event and site where the event is held. Those entering the show hall are welcome to wear a mask. We respect everyone's right to protect their health. In the event an individual tests positive within 7 days of attending a CFA show, the show manager of the show must be informed. It is then the responsibility of the show manager to ensure that notification has been made to the facility, judges, stewards, clerks, exhibitors, vendors, show personnel, and the Central Office Executive Director within 24 hours of initial notification.

Feline Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, caliciviruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, fungus, or any contagious or infectious illness. Claws of all entries must be clipped prior to benching. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.

Cages and Supplies:

Exhibitors are responsible for providing their own benching enclosures. A standard double cage is 22"x22"x45". (Show Rule 5.01) You may purchase an inexpensive pop-up for \$20 at the show hall, or bring your own. Please indicate in notes to the entry clerk if you wish to buy an enclosure at the show hall. Litter will be provided; bring your own litter pans, cat food and cat dishes.

Entry Information:

It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online/fax entries. Neither the Entry Clerk nor the Gulf Shore Region will be responsible for entries lost due to communication errors. Per show rule 6.21, all entries must be accompanied by proper entry fees. Entries sent online must be paid in full within 10 days of receipt or prior to the show, whichever is first.
