All qualifying entries must be received by October 22, 2022. This is a non vetted show. Only cats entered in the show or exhibition will be allowed in the show hall.

**CAT FANCIERS' OF HAWAII CLUB WILL FOLLOW CFA, CITY, COUNTY, STATE, AND FEDERAL COVID-19 RELATED HEALTH**

**RULES:** Entries for Championship, Premiership and Kitten classes must have registration numbers on the entry blank to be printed in the catalog. Kittens may be entered without registration numbers but will not be scored for CFA awards if the number is not provided to the Master Clerk during specified show time. No kittens under the age of 4 months or cats not entered in the catalog are allowed in the show hall. Entry Clerk will phone collect to clarify entries where necessary. Benching requests will be honored whenever possible. Only one benching request or agent per exhibitor.

Show rules will be strictly enforced. Rules may be obtained from CFA by sending \$5.00 to CFA, 260 East Main St, Alliance, OH 44601 HEALTH: This is a non-vetted show. It is strongly recommended that all entries be inoculated for protection against Feline Enteritis, Rhinotracheitis, Calici Virus and tested for FELV. All entries must be free of fungus and parasites. ALL ENTRIES MUST HAVE CLAWS CLIPPED. Declawed cats are not eligible for entry. Show management reserves the right to ask any cat or kitten to leave the show due to health concerns.

**LUNCH IS AVAILABLE FOR PURCHASE:** We will have a light lunch – sandwiches, chips, salad, drinks for a \$12 per person donation to the Club. Please include the lunch count on your entry form. We will stagger our lunch times so 2 rings will continue the show judging while the other rings take breaks for lunch.

**CHECK-IN AND SHOW HOURS:** Check in is from 7:30 to 8:00 am. **Anyone not checked in by 8:30am will be marked absent.** The show starts promptly at 10:00 am. Show hours are 10:00 am – 4:00 pm. No cage/show tent may be dismantled without the Show Manager's approval until all finals have been completed.

**SHOW HALL:** Blaisdell Hawaii Suites at 777 Ward Ave. Honolulu 96814 The show hall is air conditioned.

**AMENITIES:** Litter will be provided. Bring your own litter trays, cat food and dishes. You must also bring your own cage curtains and benching cover. Make it festive...compete in the cage decoration contest.

**BENCHING:** The single benching space is 36" wide, 24" deep. One cat or two kittens may be benched per cage. Exhibitors with enclosures wider than 36" will need to purchase a double space upgrade. It is preferred that cages be covered on all three sides and top. The dimensions of the **double space cages** provided are **22" H x 22" D X 54" W.**

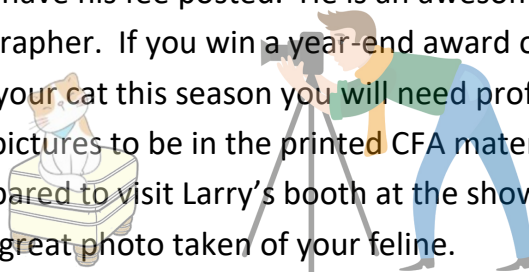
