**Show Hall:** Butler County Fairgrounds, 1717 Fairgrove Ave., Hamilton, Ohio 45011  
PH: 513/892-1423. The show hall is handicapped accessible, heated and air-conditioned as needed, free parking, & smoking prohibited.

**Check-in:** 7:30 – 8:30 a.m. Cats not benched by end of check-in will be marked absent and the exhibitor must notify clerk in each ring if the cat is present.

Judging begins: 9 a.m. Saturday and Sunday. Advertised Show Hours: 9 a.m. to 5 p.m. on Saturday and 9 a.m. to 4 p.m. on Sunday.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

**Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry." All claws of all entries must be clipped prior to benching.

**Benching:** Single cage size is approximately 22" x 22" x 22" each entry). No more than two kittens or one cat may be benched in a single cage; whether entered for exhibition or competition or benched for sale. Please bring cage curtains and grooming aids. Litter will be provided, bring your own litter box, dishes and cat food. Kittens under the 4 months old are not allowed in the show hall. Exhibitors must transport cats in/out of the show hall in an enclosed, secure carrier. Please notify the entry clerk if you are a new exhibitor... We want you to have a great show. **Airport:** Cincinnati -Northern Kentucky International Airport (CVG) (49 miles) OR James M. Cox Dayton International Airport (DAY) (53 miles). The show management intends to allow spectators. All federal, state, local and CFA mandatory COVID-19 restrictions will be observed. All attendees are expected to follow the CFA mandatory COVID-19 requirements and recommended general practices, local county, state, national and event facility regulations.
