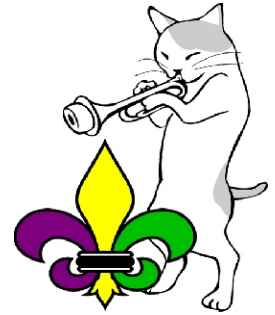

We have some fun things planned!

- Spectators are being invited. We will follow all Covid regulations in place at the time of the show. CFA/Local mandates.
- No veterinarian inspection prior to benching. You are strongly advised to have your cats inoculated against Feline Enteritis; Rhinotracheitis/Pneumonia, Calici and tested for FELV, prior to entry. All entries must be free of fungi, ear mites, parasites and all the above. The show committee reserves the right to remove any cats from the show hall, until a licensed veterinarian, at owner/agent expense, declares the cat, and all other cats at the show, in the care of that owner/agent, are cleared.
- All cats must have their nails clipped prior to benching. According to CFA rules, declawed cats cannot be shown.
- Reasonable care will be taken for cats and personal property. Show hall is locked after everyone vacates. Cats are NOT to be left in the show hall !
- Neither LSCC, its individual members, nor DuPage County Fairgrounds, shall be liable for property lost, damaged or stolen.
- Smoking is prohibited in the building.
- **This is a CFA licensed show. CFA rules will be strictly enforced.** Show rules may be obtained from CFA. All entries in Championship (except Novice;) Premiership (except Novice;) registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a HHP color class prefix, will be scored for CFA awards.
- Kittens under the age of 4 months will not be allowed in the show hall. - The club reserves the right to substitute judges.
