### GENERAL

CFA Show rules will be strictly enforced. Copy of rules may be found at <https://cfa.org/cfa-manuals/>. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. All entries in Championship (except Novice), Premiership (except Novice), Agility (if offered), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. All Agility cats that are properly entered will be scored for CFA National and Regional awards. It is the Exhibitors responsibility to check entry confirmation and notify entry clerk of any errors prior to show closing.

Egyptian Maus will be scored for Best of the Best. All Egyptian Maus will be benched together. GEMS club members will receive a free ½ cage for each entry.

### SUPPLIES

Only clay litter will be provided. Exhibitors are responsible for providing water and food for their cats.

**HEALTH AND SAFETY:** This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. This show intends to allow spectators. All federal, state, local and CFA mandatory COVID-19 restrictions will be observed. All attendees are expected to follow the CFA mandatory COVID-19 requirements and recommended general practices, local, county, state, national and event facility regulations.
