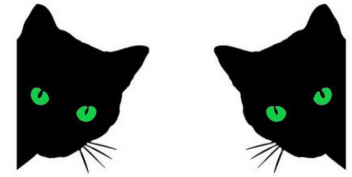

**Entry Info:** Entries are accepted now. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. All fees must accompany entries and be payable in US funds. **PayPal is available (make payment to Friends & Family) send to [indycatshow@gmail.com](mailto:indycatshow@gmail.com). The club is not responsible for PayPal fees.** Make checks payable to Indy Cat Club, Inc. **\*\*A Late Fee of \$50 will be charged on all fees not paid by 14 days after the show.** Please confirm online entries by email with the entry clerk. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE. All entries must be paid regardless of whether the cat is present at the show. Exhibitors with 1 entry/security cage must purchase the additional opening. **It is the exhibitor's responsibility to confirm with the entry clerk that their entries have been received.**

**Rules:** CFA Show Rules will be strictly enforced. Show Rules may be obtained by sending \$7 to the Cat Fanciers' Association, 260 E. Main St. Alliance, OH 44601. This show is licensed by CFA. Rosettes will be awarded for all final wins, including HHP finals. Permanent ribbons will be used. Cloth ribbons will be available, upon request, from the ring clerks. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. **Benching & Health:** Cage size: 22" x 22" x 22" (single cage) and is included with your entry. All cats must be brought in carriers. No cat may remain in carrier during show or in the show hall overnight. Litter will be provided. Bring your own litter pans. Reasonable care of cats and carriers will be provided; however, neither Indy Cat Club, Inc., nor the Hendricks County 4-H Fairgrounds will be liable for loss or damage. There will be no night watch person on duty. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. **ALL CATS/KITTENS MUST HAVE ALL CLAWS CLIPPED** prior to benching (declawed cats are not eligible for competition) **AND BE FREE OF FLEAS, MITES, AND SKIN DISEASE.** Any entry suspected of having any of the above will be requested to leave the show hall until cleared by a veterinarian, whose decision is final. **NO KITTENS UNDER 4 MONTHS OF AGE ARE ALLOWED IN THE SHOW HALL!** All household pets 8 months and over **MUST BE NEUTERED OR SPAYED.** Altered household Pet kittens (4 thru 7 months), as well as unaltered HHP kittens, may be shown in accordance with CFA Show Rules. There will be no veterinary inspection. **Show Hall:** The Show Hall Emergency Use Only telephone number is 317-927-7520. The show hall is posted NO SMOKING. The building is air conditioned and heated and handicapped accessible.
