**Show Hall/Food:** Show hall is air conditioned, heated and is handicapped accessible. Handicapped benching requests will be accommodated, at no additional charge to the exhibitor. Clerks receive priority benching and will be paid in accordance with CFA Show Rules. There is a fee for parking in the RiverCenter parking ramps. The St. Paul RiverCentre complex is a totally smoke-free environment.

**The RiverCentre Concession will have people food for sale. No outside food will be allowed in the show hall per RiverCentre regulations.** Please protect our show hall privileges.

**Scoring:** All entries must be registered with CFA (or have a TRN number), except kittens and household pets. Kittens must be registered for CFA National and Regional scoring - registration numbers must be printed in the catalog or provided to the Master Clerk. All Championship, Premiership and registered Kittens will be CFA scored. No kitten under 4 months of age will be allowed in the show hall; exhibitors must have litter registration available to verify kitten's age. Only 2 cats or 4 kittens allowed per double sales cage. This show is conducted under the current CFA rules. Rules can be downloaded for free from the CFA website at <https://cfa.org/wp-content/uploads/2023/04/23-24show-rules.pdf>

**Vetting:** All cats must be free from fleas, ear mites or any infectious or contagious illness. You are strongly advised to have your cat inoculated by a licensed veterinarian against panleukopenia, feline rhinotracheitis, calici viruses and rabies and tested for feline leukemia virus before entry. Front and rear claws must be clipped prior to benching. No declawed cats may be entered.

**Supplies:** Litter will be furnished. Please bring your own litter pan, also your own cat food, water and food dishes.

**Cages:** See note on front about **Cageless Show**. Approximate cage space is 24" x 24" (single cage space included with entry). Second entry by same owner will be benched in the other half of a security cage, or the other half benching space may be purchased for extra \$20. Single entries with any size security cage require the purchase of an extra half cage space. Single security cage spaces are NOT available. Wire cages may be reserved if available. Single entries will require the purchase of an extra half benching space to accommodate the cage.
