ENTRY INFO: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. Fees must accompany entries and no fees will be refunded due to failure to bench. No postdated checks will be accepted. Kittens must be four months of age or older on the opening day of the show. **In the event the show fills before closing, the club will accept entries for a waiting list as follows: Any entry received with payment in full will be given priority, followed by email entries with a time and date header. Show Rule 6.21 regarding payment for fax and email entries will be enforced.**

COVID RESTRICTIONS: Spectators and vendors will be allowed per local restrictions and may be required to wear masks over nose and mouth.

ENTRY FEES: PayPal is Preferred method of payment using "Friends/Family". The club is NOT responsible for PayPal fees for funds submitted incorrectly. PayPal address is "**EntriesLPCC@yahoo.com**". Checks payable to: **Lucky Penny Cat Club**. First entry fee includes show catalog. **An Additional fee of \$20 will be charged if fees are not received within 10 days of receipt of entry. For other entries payment required one day prior to the show.** There will be a \$35.00 fee charged on all returned checks. No refund for failure to bench.

CLOSING DATE: October 30, 2023 (Monday - 9PM PT), OR WHEN 225 LIMIT IS REACHED. EB closes 9/30/23.

HEALTH: This is a non-vetted show. It is strongly recommended that all entries be tested for feline leukemia and inoculated for protection against feline enteritis, rhinotracheitis, calici virus, and chlamydia. All entries must be free of fungus and parasites. **Each Entry Must Have All Claws Clipped.** Declawed cats not eligible for entry.

AMENITIES: Litter will be provided. Please bring your own litter trays, food, and dishes.

CAGES: Exhibitors are required to bring their own Cages. Cage/Groom size is 36" wide and 24" deep. Any cage larger than 36" in length will require the purchase of a groom space to accommodate the cage. If no groom space is purchased and the cage does not fit in the space allotted you may be required to purchase one of the limited pop ups available for sale at a cost of \$20. No more than one cat or two kittens may be benched in the same cage.

AWARDS: Ribbons and rosettes will be awarded in accordance with CFA show rules. Permanent flats will be used with satin flats available upon request. For a copy of the current CFA show rules, send \$7.00 to the Cat Fancier's Association, 260 E Main St., Alliance, OH 44601, or go to <https://cfa.org/wp-content/uploads/2022/03/22-23show-rules.pdf> for latest show rules. The club reserves the right to add judges not named to judge non-championship, Household Pet and veteran classes.

SHOW HOURS: Early check-in on Friday, November 03, 2023, from 12:00 PM to 3:30 PM. Saturday check-in from 8:00 AM to 9:30 AM. Judging begins promptly at 10:00 AM. Advertised show hours are 10:00 AM to 5:00 PM. No cage may be dismantled without the show manager's approval until all judges have completed their finals. GRAND PARTIES with show manager permission only.

HOUSEHOLD PET INFO: Household pets 8 months of age or older must be spayed or neutered. ALL nails must be clipped, and cats should be bathed. Contact the show manager if this is your first show and you have questions.

VETERANS: Must be a pedigreed cat and at least 7 years old to be entered in this class.

SHOW HALL INFO: Ventura County Fairgrounds (San Nicolas Hall), 10 West Harbor Blvd., Ventura, CA. Show hall is heated and has ample free parking for exhibitors and vendors. A link will be included in your entry to receive a parking pass. Smoking is not permitted in the show hall. From the North, take 101 Freeway South. Take exit 70A towards Ventura Ave, Keep right onto Thompson Blvd, Turn Right onto Figueroa St. Pass the Fair marquis and turn right into the parking lot entrance. From the South, Take 101 Freeway North. Take exit 70A onto California St. and turn left. Turn right onto Harbor Blvd, Turn Left onto Figueroa St. Pass the Fair marquis and turn right into the parking lot entrance. From the East, take 126 Freeway West to 101 Freeway North and follow directions 'From the South'. Show is in San Nicolas Hall.
