



NEW Show Hall: John S. Knight Center 77 E. Mill St. Akron, OH 44308 Ph: 330-374-8900. The show hall is handicapped accessible. Heating/Air-conditioning as needed. No smoking and no vaping. Food service will be available. **Absolutely no outside food in the show hall.** Free parking with skywalk and elevator.

Payment & Entry Info: Entries are accepted now. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Cleveland Persian Society. Returned Check Fee \$50 (+ all bank fees). PayPal will be accepted (prior to closing) send to <u>clevperssoc@gmail.com</u> payments should be sent as "Friends and Family". Please confirm online entries and PayPal payments by email (rather than phone) with the entry clerk. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE.

Check-in: 7-8 am Cats not benched by end of check-in will be marked absent and the exhibitor must notify the clerk in each ring if the cat is present. **Judging will begin** at 8:30 am on Saturday and at 9 am on Sunday.

Advertised Show Hours: 8:30 am – 3 pm on Saturday; 9 am – 4 pm on Sunday.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

Benching: Single cage size is approximately 22" x 22" x 22" (and is included with each entry). No more than two kittens or one cat may be benched in a single cage whether entered for exhibition or competition or benched for sale. **Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage.** Please bring cage curtains and grooming aids. Litter will be provided; bring your own litter box, dishes and cat food. Kittens under 4 months old are not allowed in the show hall. Exhibitors must transport cats in/out of the show hall in an enclosed, secure carrier.

Hotel Info: List will be sent with your confirmation.

Airport Info: Akron-Canton Airport (CAK) is17 miles to show hall. Cleveland Hopkins Airport (CLE) is 42 miles to show hall.
