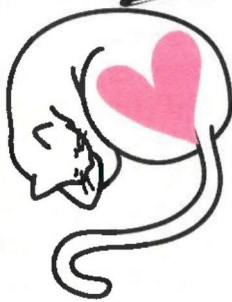

Entry Info: All entries must be submitted on an official CFA entry form, printed or typed clearly. Online entry available at entries.cfa.org/onlineEntry.php. All checks must be drawn on US banks and in US Funds. Please make checks payable to Hawkeye State Cat Club. Hawkeye State does accept Square payments. The information will be provided in your confirmation. Payment is expected PRIOR to the show. NO payment at check-in.

Per show rules, all entries must be paid whether in attendance or not. No refunds for failure to bench. Only one benching request can be honored.

Reminder: If you are using the online entry: It is each exhibitor's responsibility to email the entry clerk to be sure all of your entries have been received. If you do not email the entry clerk, and receive a reply, there is no guarantee that your entries have been received. Please try to give our entry clerk a minimum of 24 hours to reply.

This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Panleukopenia, Rhinotracheitis, Calici Virus, and Rabies. FELV testing is recommended. All claws must be clipped, front and back. DECLAWED cats are not eligible for competition.

No Smoking is permitted in the Show Hall. Litter will be provided. Please bring your own litter pans, food, dishes, and cage curtains. *Wire benching cages are available for exhibitor use. The exhibitor will be responsible for setting them up. Cage sizes are 21"x21"x21". Double Cage size is 21" x 21" x 45".* No more than one cat or two kittens may be benched in a single cage. Only cats entered in the show or for sale by an exhibitor may be present in the show hall. Hawkeye State Cat Club and Wild Rose Cat Club will take reasonable care to safeguard the property of exhibitors. Neither the clubs, their members nor The Iowa State Fair will be liable for any loss or damage. The show hall is handicapped accessible and is equipped with both heat and air conditioning. Although our show hall is handicapped accessible, the Iowa State Fairgrounds does not have designated handicapped parking immediately next to the building. Those in need of assistance should contact the club for aid in unloading and parking. Food will be available.

The club has a block of rooms reserved at the Econo Lodge Inn and Suites, 410 E. 30th St, Des Moines, IA 50317. To receive the club rate, exhibitors must call the hotel directly at (515) 262-2525.

CFA Info: All entries in Championship (except Novice), Premiership (except Novice), Registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats or kittens without registration numbers can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers but will not be scored for CFA awards. This show is licensed by The Cat Fanciers Association, Inc. All CFA rules will be strictly enforced. A copy of the current CFA Show Rules may be obtained by sending \$7 to Cat Fancier's Association, 260 E. Main St. Alliance, OH 44601 or online at www.cfa.org/client/formsmanuals.aspx.

Ribbons and rosettes will be offered in all rings as required by CFA Show Rules. CFA approved Permanent Flats will be used. There will be a special award for the two highest scoring Household Pets.
