Entry Info: Entries are accepted now. You must enter online www.entries.cfa.org Entry Fees include CFA & Regional surcharges. Please email entry clerk to confirm online entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. If you don't receive an emailed confirm within 24 hours of entering please confirm online entries by email with the entry clerk. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE.** No substitutions after the closing date. **No refunds after the entry clerk has confirmed your entry or for failure to bench/attend the show.**

Payment Info: Make checks payable to Just Cat in Around. **Return Check Fee \$50 + all bank fees.** Mail checks to Sabrina Grisier, 303 Stryker Street, Archbold, OH 43502. **CASH ONLY for entry fees paid at the door at check-in.** PayPal info will be sent with your confirm. PayPal is accepted; send to Friends and Family at justcatinaround@gmail.com **ALL fees paid at the door must be in CASH. A Late Fee \$25 will be added to any fees paid after 4/27/24.**

Show Hall: Taylor Sportsplex 13333 Telegraph Rd. Taylor, MI 48180 Ph: 734-374-5838. The show hall is heated/air conditioned as needed. This is a NON-SMOKING show hall. Parking is Free.

Check-in: 7:30-8:30 am, any cat not benched by 8:30 will be marked absent. Please report any transfers or absentees at check-in. Judging will begin at 9 am both days. All adult entries must remain in the show hall during advertised hours of 9 am – 4 pm (or until completion of judging) both days.

Local Hotel Info: There are lots of "Pet Friendly" hotels in the Taylor & Romulus area. Contact hotel directly to confirm any pet fees or restrictions.

Local Airport Info: Detroit Metro Airport (DTW) is approximately 15 minutes from the show hall.

Benching: Single cage size is approximate 22"x22"x22"; and is included with your entry. **Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage.** Please bring cage curtains (or coverings) to cover the sides, top and bottom of cage. Cat litter will be provided; please bring litter box.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Household Pets: All Household Pets over the age of 8 (eight) months must be neutered or spayed. HHPs may not be declawed.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. *Just Cat-In Around Cat Fanciers reserve the right to substitute judges in case of illness or emergency*
