**Payment & Entry Info:** Entries are accepted now. You must enter online <u>www.entries.cfa.org</u> Entry Fees include CFA & Regional surcharges. Please email entry clerk to confirm online entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to Lincoln State Cat Club. Returned Check fee \$50 + all bank fees. Square payments will be taken by entry clerk & invoice

emailed to you. Please have **EXACT CASH** if paying at the door. If you don't receive an emailed confirm within 24 hours of entering please confirm online entries by email with the entry clerk. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE CLOSING DATE.** No substitutions after the closing date. <u>No refunds after the entry clerk has confirmed your entry or for failure</u> to bench/attend the show.

Set-Up: Vendors and exhibitors will be able to set-up on Friday February 23, 2024 2 - 6 pm.

**Check-in:** 7:30-8:30 am on Saturday. Cats not benched by end of check-in will be marked absent and the exhibitor must notify the clerk in each ring if the cat is present.

Judging Hours: 9 am - 5 pm Saturday. 9 am - 4 pm Sunday. Advertised Show Hours: 10 am - 4 pm.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed, and NOT declawed.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

**Benching:** Single cage size is approximately 22" x 22" x 22" (and is included with each entry). No more than two kittens or one cat may be benched in a single cage whether entered for exhibition or competition or benched for sale. **Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage.** Please bring cage curtains and grooming aids. Litter will be provided; bring your own litter box, dishes and cat food. Kittens under 4 months old are not allowed in the show hall. Exhibitors must transport cats in/out of the show hall in an enclosed, secure carrier.

**Show Hotel:** Hilton Garden Inn 4070 E Main St. Saint Charles, IL 60174. Room Rate is \$114 + taxes and a **\$50 pet fee**. Show Hotel Rate includes full breakfast starting at 6 am both days. Call the hotel directly 630-584-0700 and ask for the Lincoln State Cat Club rate.

Airport Info: Chicago O'Hare International Airport (ORD) is about 30 miles/45 minutes from the show hall.
