CATS HEALTH

According to Hong Kong Agriculture, Fisheries and Conservation Dept. that all cats and kittens entered or present in the show hall MUST be inoculated at least 14 days (on or before JAN 13, 2024) prior to show date by a licensed veterinarian AGAINST:

#1 Feline enteritis, feline rhinotracheitis & calici viruses & #2 Rabies

A valid Vaccination certificate must be presented during check in and indicating NEXT VACCINATION DUE DATE ON or AFTER JAN 13, 2024
