**Entry Info:** Entries are accepted now. Entry Fees include CFA surcharges. Please email entry clerk to confirm online entries. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. **Make checks payable to "NNDCC";** US\$ checks only and please mail to entry clerk. **Cash is required for any payments made at the door.** No refunds after the entry clerk has confirmed your entry or for failure to bench. No substitutions after the closing date. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE. Please advise the entry clerk if this is your first show and visit <http://www.cfaneewbee.org>**

**Check-in:** Saturday 7:30-8:30 am **Show Hours:** Judging will be at 9 am – 4 pm both days. **Spectator Hours:** 10 am – 4 pm both days.

**Show Hall:** Use Exit 69B Rt 206 South: National Guard Armory 151 Eggerts Crossing Rd. Lawrenceville, NJ 08648 Ph: 609-234-3681. Parking lot entrance. Free parking. Hall is heated and wheelchair accessible. Food: TBA.

**Show Hotel:** Right off I-295, 10 minutes from the show hall! Element, by Westin, a Marriott property, 1000 Sam Weinroth rd., Ewing Township, N J 08628. Phone: 1-609-671-0050. Be sure to speak with the front desk and ask for the room block for National Norwegian Cat show. The rate is \$89 a night plus tax, no pet fee. Most of the rooms are Suites, and have full-size refrigerators in them, there is an indoor pool (which may or may not be open) breakfast is included.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

**Benching:** Single cage size is approximately 22"x22"x22" (included with entry). **Use of ANY size security cage with a single will require purchase of an extra 1/2 cage space.** Bring cage curtains (or coverings) to cover the sides, top and bottom. Litter will be provided but not litter pans. No single space at EOR.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

The show will be conducted in accordance with current CFA show rules. Show rules are from CFA, 260 East Main St. Alliance, OH 44601.
