All Championship, Premiership, except Novices; all registered kittens; all recorded Household Pets and registered cats competing as HHPs with a color class prefix; all **Agility** cats properly entered, will be scored for CFA National and Regional awards.

**All checks must be drawn on US bank or paid in US funds.**

**Starting Times:** The show hall will be open at 7:30 a.m. All cats must be benched by 8:30 a.m. or they will be marked absent. Judging will begin **promptly** at 9:00 a.m. on both days. All entries must remain in the show hall until 4 p.m. unless permission is received from the show manager.

**Any cancellation must be 24 hours in advance of check-in.** There is no airport shuttle from the hotel. We recommend Uber.

All entries should be inoculated against Feline Panleukopenia, Rhinotracheitis, and Calici Virus and Rabies and tested for FeLV by a licensed vet. Cats should be free of mites, fleas, and fungus. CFA rules require your cat's front & back claws be clipped.

Our show is held under the auspices of the Cat Fanciers' Association. CFA show rules will be strictly enforced. A copy of the rules is available for \$7.00 from CFA, 260 Main St., Alliance, OH 44601. {[www.cfa.org](http://www.cfa.org)}

Litter will be available. Please bring your own litter pan, water bowl and cat food. People food will be available. Cats may not be left in the show hall overnight. The club will exercise due care in the sponsorship of the show, but will not be liable for any loss, damage, or injury. No security will be provided during the hours the show is not open. Our show hall is heated and air conditioned. Smoking is not permitted. Directions will be sent with your confirmation.
