Entry Info: All entries must be submitted through the CFA online entry form on the CFA website. Per show rules 6.21 & 6.20, all online entries must be paid in full within ten (10) days of receipt or prior to the start of the show, whichever is first. Cash, check or money orders accepted only. The use of the online entry form is interpreted as an official entry in this CFA Show and the email address on the form is your signature. Entry Fee includes CFA surcharges. No withdrawing entries once they are entered. No refunds after the entry clerk has confirmed your entry or for failure to bench. Entries will begin to be accepted upon publication of this flyer.

Owners Responsibility: Please verify with the entry clerk that your entry has been received. Please email the entry clerk meloncali@comcast.net to confirm online entries. Check your confirmation for accuracy! *Please contact the entry clerk with any corrections BEFORE CLOSING DATE.*

Show Hall: Butler County Agricultural Society, 1715 Fairgrove Ave. Hamilton, OH 45011 Ph. 513- 892-1423. The show hall is handicap accessible, heated & air-conditioned (as needed). This is a Non-Smoking facility. Smoking is not permitted where cats are benched or judged. This includes smoking of any kind, including but not limited to cigarettes, cigars, e-cigarettes and vaping. Concession stand will have food available for breakfast and lunch.

Check-In: Saturday 7:30AM -8:30AM with judging to start at 9:00AM both days. Cage size is 22"x22"x22" (single) and is included with entry. Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage. Litter will be provided, but not litter pans. Cats not benched by 8:30 am will be marked absent and exhibitors must check in with the clerk in each ring. Advertised show hours are Saturday 9AM-5PM, Sunday 9AM-4PM or end of finals both days.

Benching Requests: Every effort will be made to honor your requests. A clerk near their ring is not counted as a request.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws must be clipped prior to benching. Declawed cats are not eligible for competition.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, registered Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. By entering, exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7 each from CFA, 260 E. Main St. Alliance, OH 44061.

Airport Info: Cincinnati/Northern Kentucky International Airport (CVG) is about 44 miles from the show hall. James M. Cox Dayton International Airport (DAY) is about 53 miles from the show hall. Exhibitors are responsible for their own transportation.
