**Entry Info:** Entries accepted now. Entry fees include CFA surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. **Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE.** No substitutions after the closing date. **No refunds after the entry clerk has confirmed your entry or for failure to bench.**

**Payment Info:** Make checks payable to Colonial Annapolis. No PayPal. US bank checks only. **Returned Check Fee is \$50 + bank fees. A Late fee of \$50 will be added to ANY fees not paid by after 6/15/24. TO EXPEDITE THE CHECK-IN PROCESS CASH ONLY AT THE DOOR.**

**Show Hall:** Tall Cedars of Lebanon 2501 Putty Hill Ave (Corner of Old Harford Road) Parkville, MD 21234 410-668-4545. The show hall is located off the Perring Parkway, Exit 30 of the Baltimore Beltway. The show hall is a NON-SMOKING facility and is heated. **FREE PARKING.**

**Benching:** **\*\* Grooming space, sales cages & end of row space is extremely limited. Sales cages are only available WITH a paid entry.** Single cage size is approximately 22" x 22" x 22" and is included with your entry. **EOR only available with even numbered entries or paid extra ½ cage. Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage.** Litter is provided, bring litter boxes.

**Check In & Show Hours:** Check-in on Saturday 8 - 9:30 am; Cats not benched by 9:30 am will be marked absent, report any transfers or absentees at check-in. The show will start at 10 am on Saturday and at 9 am Sunday. The show hall will open at 8 am Sunday. **Show Hours:** 10 am - 4 pm Saturday and 9 am - 3pm Sunday.

**Household Pet Entries:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition. Under MD State law a rabies vaccine is required for all cats over the age of 4 months.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.
