## \*CATS HEALTH\*

According to Hong Kong Agriculture, Fisheries and Conservation Dept. that all cats and kittens entered or present in the show hall MUST be inoculated at least 14 days (on or before July 20, 2024) prior to show date by a licensed veterinarian AGAINST: #1 Feline enteritis, feline rhinotracheitis & calici viruses & #2 Rabies

A valid Vaccination certificate must be presented during check in and indicating NEXT VACCINATION DUE DATE MUST BE ON or AFTER AUG 5, 2024

FOR OVERSEAS SHOW CATS please refer AFCD regulations for import requirements to Hong Kong: AFCD-Guideline For Import & Export animals

Formal VET Checking-in prior to benching will be enforced. Any cat(s) without checking-in at the show reception OR failed to fulfil the above requirements are not allowed to enter the show hall. NO other animals are allowed to enter.
