ENTRY INFO: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number. Fees must accompany entries and no fees will be refunded due to failure to bench. No postdated checks will be accepted. There will be a \$35.00 fee charged on all returned checks. Kittens must be four months of age or older on the opening day of the show. **In the event the show fills before closing, the club will accept entries for a waiting list as follows: Any entry received with payment in full will be given priority, followed by email entries with a time and date header. Show Rule 6.21 regarding payment for fax and email entries will be strictly enforced. Additional fees will be charged if fees are not received within 10 days of receipt of entry. No payment at check-in. [CHECK THIS-WILL YOU TAKE CHECK-IN PAYMENT?]**

CLOSING DATE: Monday, April 7, 2025, OR when entry limit is reached.

HEALTH: This is a non-vetted show. It is strongly recommended that all entries be tested for feline leukemia and inoculated for protection against feline enteritis, rhinotracheitis, calici virus, and chlamydia. All entries must be free of fungus and parasites. **EACH ENTRY MUST HAVE ALL CLAWS CLIPPED.** Declawed cats are not eligible for entry.

AMENITIES: Litter will be provided. Please bring your own litter trays, food, and dishes.

CAGES: NO CAGES ARE PROVIDED. Cage size is 22" for a single, 45" for a double. No more than one cat or two kittens may be benched in the same cage.

AWARDS: Ribbons and rosettes will be awarded in accordance with CFA show rules. Permanent flats will be used with satin flats available upon request. For a copy of the current CFA show rules, send \$7.00 to the Cat Fancier's Association, 260 E Main St., Alliance, OH 44601, or <https://cfa.org/wp-content/uploads/2024/03/24-25show-rules.pdf>. The club reserves the right to add judges not named to judge non-championship, Household Pet and veteran classes.

SHOW INFORMATION AND HOURS: Check in is from 7:30 – 8:30 a.m. The show will begin promptly at 9:00 a.m. and is scheduled to end at 4:30 p.m. on Saturday and 9:00 – 4:00 p.m. on Sunday.

HOUSEHOLD PET INFO: Household pets 8 months of age or older must be spayed or neutered. ALL nails must be clipped and cats should be bathed. Contact the show manager if this is your first show and you have questions.

VETERANS: Must be registered and at least 7 years old to be entered in this class.
