ENTRY INFO: You are required to enter online in compliance with CFA Show Rules. No substitutions will be accepted after the closing date. **Check your confirmation for accuracy and notify the entry clerk of any errors prior to the closing date.** There will be no refunds after your entry has been confirmed or for failure to attend the show. By entering exhibitors agree to abide by the decisions of the judges and show committee and to adhere to CFA show rules.

SHOW HALL: Dixon May Fair Fairgrounds 655 South First Street, Dixon, CA 95620. 707-678-5529. This show hall does have heating. It is handicapped accessible. This is a **NON-SMOKING** and **NO ALCOHOL** hall. There will be a food truck parked outside of the hall with food for purchase.

Directions From the North: Take I-80 west to exit 66A CA 113 South to Dixon. Take a slight right onto CA 113 until you see the May Fair on the left.

Directions from Sacramento Airport: Take I-5 North. Exit on E Main Street (exit 537). Turn left and continue past Carl's Jr. Take a left onto CA-113 South to Davis. Follow the 113 south and stay in the left lanes to take I-80 West. Take exit 66A for CA-113 S toward Dixon. Slight right onto 113 and follow until you see the May Fair on your left.

Directions from the South: Take I-80 East toward Sacramento. Exit on Midway Rd (exit 60). Follow Midway to 113 north and turn left. The May Fair will be on your right.

BENCHING: This is a bring your own benching enclosure show. Pop Up enclosures will be available for \$20 for those exhibitors without their own enclosures and will need a double space. Let the entry clerk know prior to show closing if you will need one. A single cage space is 22" X 24". A double cage space is 44" X 24". No more than one cat or two kittens may be benched in a single space. Every entry includes a single cage space. Litter will be provided. Bring your own cage drape, bottom sheet, litter pans and food and dishes.

CHECK IN AND JUDGING: Check in will be from 7:30 AM to 8:30 AM. Judging will begin promptly at 9:00 AM and will end at 4:00 PM. Advertised show hours are 10:00 AM to 4:00 PM

HEALTH: This is a non-vetted show. It is strongly advised that all cats and kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fungus and parasites. All claws must be clipped prior to benching. De-clawed cats are not eligible for entry and will not be admitted to the show hall.

HOUSEHOLD PETS: Household Pets must be 4 months of age or older on the first day of the show. Cats 8 months of age or older must be spayed or neutered. Cats should be bathed.

AWARDS: Ribbons or Rosettes will be awarded in accordance with CFA Show Rules. Any donation to the ribbon and rosette fund will be appreciated and acknowledged in the catalog.

CFA RULES: CFA show rules will be strictly enforced. The current CFA Show Rules are available online at <https://cfa.org/wp-content/uploads/2024/05/24-25show-rules.pdf> and may be downloaded for free. A print copy may be obtained by sending \$7.00 to the Cat Fanciers' Association, 260 East Main Street, Alliance, OH 44601. All adult cats entered must be registered with CFA and their registration numbers included on the entry form. No fees will be refunded for failure to bench. Benching request will be honored wherever possible. One benching request or agent per exhibitor. The club reserves the right to add judges not named to judge non-championship and Household Pet classes. Kittens must be 4 months of age or older on the opening day of the show. The CFA Northwest Region and the Dixon May Fair will not be responsible for damage, loss, personal injury, or loss of personal property. No cats may be left overnight in the show hall. There will be no vending from cages or groom spaces. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number prior to the show date. Kittens may be entered without registration numbers but will not be scored for CFA awards if a number is not provided at show time.

SHOW HOTEL: There is no official show hotel. The cities of Dixon, Davis and Vacaville are nearby. The following hotels are provided for your convenience but are not being recommended. Check the reviews.
