IN ACCORDANCE WITH CFA RULES, FEES FOR ALL ENTRIES MUST BE PAID WITHIN 10 DAYS OF ENTERING, OR PRIOR TO THE FIRST DAY OF SHOW, WHICHEVER COMES FIRST. NO PAYMENTS ACCEPTED AT CHECK-IN. MAIL CHECKS TO ENTRY CLERK (SEE ABOVE), OR PAY USING SQUARE. **NO REFUNDS FOR FAILURE TO BENCH. A SQUARE INVOICE FOR ENTRY FEES WILL BE SENT WITH YOUR EMAIL CONFIRMATION. The RiverCentre Concession will have people food for sale. No outside food will be allowed in the Show Hall per RiverCentre regulations. The St. Paul RiverCentre Complex is a totally smoke-free environment. Please help protect our Show Hall.

All entries must be registered with CFA, except Kittens and household Pets. Kittens must be registered for CFA National and Regional scoring - registration numbers must be printed in the Show Catalog or provided to the Master Clerk. All Championship, Premiership and registered Kittens and Household Pets will be CFA scored. SCCC reserves the right to add judges not named to judge Non-Championship and Non-Premiership classes.

**Parking & Hotel:** A link to parking information will be sent with your entry confirmation. Please make hotel reservations early as it is Winter Carnival time and hotel rooms will be at a premium. Our show hotel is Hampton Inn & Suites, 200 W 7th Street, St Paul MN. They have reserved a block of rooms for our exhibitors; \$121 + tax per night. Call for reservations 651-224-7400. They will hold the block until January 9, 2025. There are fees for parking and for pets in the hotel. There are additional pet-friendly hotels in the area.

**Cat Health:** This is a non-vetted cat show. It is strongly advised that all cats or kittens be inoculated before entry by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici viruses and rabies. It is recommended that you bring your cats' rabies certificates in case they are needed. It is also strongly recommended that cats and kittens be tested for FeLV before entry. Any entry from a house or cattery where there has been any infectious/contagious illness within 21 days prior to the show is prohibited from the show hall. All claws, front and rear, of each entry must be clipped prior to benching. Declawed cats and kittens are not eligible for entry. All Household Pets over the age of 8 months must be spayed or neutered.

No kittens under the age of 4 months will be allowed in the show hall. Cats and kittens not entered in the show, or in prearranged sales cages, will not be permitted in the show hall.

**Cages:** Approximate size is 22 x 22 x 24" (single cage, one-half of a double wire cage, included with entry). Exhibitors using security cages for a single entry must pay for one extra half cage, as the security cage takes up the space of a double cage. If you are entering 3, 5, or 7 cats, the extra half cage is complimentary. Litter will be provided by the show. Bring your own food, bowls, and litter pans. Please note that if entering only one cat and using a wire cage, someone else's cat may occupy the other half unless you pay for the extra half cage.

Reasonable care will be taken for all cats and personal property; SCCC cannot be held responsible for items lost or damaged.

One benching request per exhibitor. Requests for end-of-row will be accommodated as space allows, on a first- entered-first served basis. Clerks get priority benching and will be paid in accordance with CFA Show Rules.
