Exhibitors should bring their own litter trays, cat food and dishes. Novice exhibitors, you need to bring cage curtains or towels. Single cage size is 22" x 22" x 22", double cage size is 44" x 22" x 22".

Hotel Information: There is no show hotel. But there are several hotels that take cats (double check) on the N. Interstate Service Drive, Belleville, MI 48111. Conveniently located west off of I-94 and Belleville Road exit. Lots of restaurants on Belleville Rd. just north of I-94. The city of Ann Arbor itself is fairly close to the show hall too.

ROSETTES AND RIBBONS will be awarded in accordance with CFA show rules, which will govern the show. A copy of the rules and show standards is available for a nominal fee from CFA 260 E. Main St. Alliance, OH 44601 All rings will use permanent ring designations. All championship, premiership, kitten and HHP entries with registration numbers or recorded numbers will be scored for CFA National and Regional points. Owners of Novices should contact the entry clerk for current entry procedures.

SHOW MANAGEMENT will take reasonable care of cats and carriers, but neither Anthony Wayne Cat Fanciers nor Washtenaw Community College will be held liable for any loss or damages.

HEALTH It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhino tracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.
