**Payments:** All fees must accompany entries. No post-dated checks or checks at the door will be accepted. Online entries must be paid in full within ten days of receipt or prior to the start of the show, whichever is first. Please make checks payable to “**Meowy Wow Wow Cat Club or MWWCC**”. Cash at the door is accepted. **Zelle to MeowyWowWowCats@gmail.com**. There will be no refund after the entry clerk has confirmed your entry or for failure to bench. Check your confirmation for accuracy and contact the entry clerk with any corrections before the closing date.

**Show Hall:** Montgomery County Fairgrounds – Exhibit Hall. 645 Infirmary Drive, Dayton, Ohio 45417 \*\*b937/224-1619  
The show hall has heating and air conditioning as appropriate. Food service will be available. Smoking or vaping is not permitted in the show hall. The show hall is handicapped accessible. Exhibitors with disabilities are responsible for making their special needs known to the entry clerk.

**Show Hours:** Check-in 7:30-8:30 Saturday. Cats not benched by the end of check-in will be marked absent and the exhibitor must notify each ring if the cat is present. Judging will begin at 9:00 both Saturday & Sunday. Advertised show hours will be 9 – 4, both days.

**Hotels:** Days Inn, by Wyndham, 20 Rockridge Rd., Englewood, OH 45322, \$109/night & \$10 pet fee, 937/832-2222. SpringHill Suites Dayton Vandalia \$139/night (pet fee waived), 937/280-4150. Hampton Inn & Suites Dayton Vandalia \$134/night (pet fee waived), 937/387-0598. Mention the “CFA Cat Show” to access these rates. The cutoff for special rates/room blocks is 3/1/25, so reserve early. There are also many other pet friendly hotels in the Dayton area. A list of potential hotels will be included with your confirmation. UPDATE: An additional hotel with a special early (until **2/28/25**) is the Drury Inn & Suites Dayton North, 6616 Miller Lane, Dayton OH 45414 (Group #10138103), 937/454-5200, \$117/night (pet fee \$50/night.)

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a “Temporary Registration Number.”

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus, and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped before benching. Declawed cats are not eligible for competition.

**Cages and Supplies:** Exhibitors must provide their own benching enclosure. Single cage spots are 22”X22”X22” and double cage spots are 22”X22”X45”. **Security cages for a single entry require the purchase of an extra half cage.** Benching requests made at time of entry will be honored when possible. Bring your own cat food, dishes and litter pans - litter will be provided.

**Liability:** Reasonable care of cats and other property will be provided. However, The Meowy Wow Wow Cat Club will not be liable for any loss or damage to a cat, exhibitor, or their personal property. [No cats may be left in the show hall overnight.](#)

**Airport:** Dayton International Airport (DAY) is 18.4 miles from the show hall. The club is not able to provide transportation

**Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.
