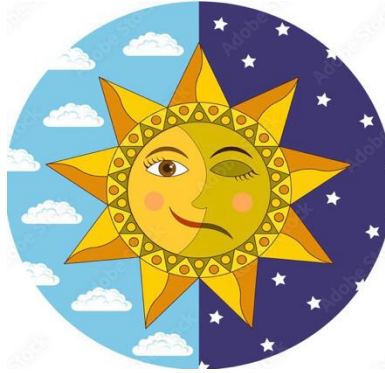

Owner's Responsibility: Please verify with the entry clerk that your entries have been received.

Show Hall: Torrington Armory, 153 S. Main St., Torrington, CT 06790. The show hall is heated or air-conditioned as needed and is handicap accessible.

Show Hours: Check in Saturday 7:00-8:00 with judging starting promptly at 8:30. Judging will start at 9:00 Sunday. Show hours are 9:00 am – 4:00 pm.

Benching Requests: Every effort will be made to honor your benching requests to the best of our talents, but at least one request per exhibitor is guaranteed.

Payment Info: Please make checks payable to North Atlantic Region and mail to Doreann Nasin, 89 Doctor Nott Rd., Franklin, CT 06254. Contact Doreann for Venmo payments. Per show rules 6.21 and 6.20, all entries must be paid in full within 10 days of receipt or prior to start of show, whichever is first. \$50 fee for any returned checks. **Only cash (USD)** will be accepted at check-in. Payments not received by 7-5-25 for failure to show will incur an additional \$25 late fee.

Hotel Information: Additional hotels will be provided with confirmation. Days Inn by Wyndham, 492 E Main St., Torrington, CT accepts pets with a \$50 per night non-refundable pet fee. Book on hotel website, use CFA Code 1000026977.

Transportation: Exhibitors are responsible for their own transportation.

Food: Concession stand will have food available. No alcohol is allowed to be sold or consumed.

Miscellaneous: Show management will take reasonable care of cats and carriers but will not be responsible for damage or loss. This is a Non-smoking facility. Benching cage size 22x22x22. Litter provided, bring your own litter pans.

Vetting: It is strongly advised that all cats or kittens present or entered in the show be inoculated by a licensed veterinarian against feline panleukopenia, rhinotracheitis, calicivirus and rabies. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Scoring: All entries in championship (except novice), premiership (except novice), registered kittens, recorded household pets, and registered cats competing as household pets with a household pet color class prefix will be scored for CFA awards. Owners of novice can contact the entry clerk for a temporary registration number.
