**Hotel & Lodging Info:** We do not have an official show hotel but there are many pet friendly hotels in Eugene/Springfield. LaQuinta in Eugene 1-541-344-8335 accept cats. **Show Rules:** The show will be conducted in accordance with current CFA show rules. These may be obtained online at <https://cfa.org/wp-content/uploads/2025/04/25-26show-rules.pdf> or send \$7.00 plus \$2.00 postage to CFA, 260 East Main Street, Alliance, OH 4460. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices or unregistered cats can contact the entry clerk for assistance and/or a temporary registration number. Ribbons and/or rosettes will be awarded according to CFA show rules. No kitten under the age of four months will be allowed in the show hall. Blue slips may be required for proof of age.

**Entries:** Make checks or money orders payable in U.S. funds to Patricia Stewart. PayPal Address is [mountainmistcat@gmail.com](mailto:mountainmistcat@gmail.com) Friends/Family method. CFA show rules state that entry fees must be paid within 10 days after entering or the day of the show whichever is first. There will be a late fee charge of \$25.00 if payment is not made on or before April 18, 2026.

**Per CFA rules, all Entries must be made via the CFA online entry portal in eCATS. Effective 4/1/25, all kitten, championship and Premiership entries must have registration or TRN numbers. TRN numbers are available on the entry page. Call the entry clerk for clarification or assistance with entries.** The Entry clerk may call or email for entry clarification. PayPal is available for this show.

**Health:** This is a non-vetted show. We ask that all cats or kittens entered or present in the show hall be current on all vaccinations (FVRCP, FeLV, Rabies,). It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Front and back claws must be clipped before benching. Declawed cats are not eligible for entry. All cats are expected to be free of fleas, mites, and infectious illnesses. Show management reserves the right to have any cat showing signs of illness, disease or parasites removed from the show hall in order to protect other cats in the show hall. No kittens under the age of 4 months will be allowed in the show hall.

**Household Pets:** Household pets are eligible only for awards in the Household Pet Class. Household pets are to be judged separately from all other cats, solely on beauty and condition. Wild cats or wild cat-domestic hybrid crosses are not eligible for entry. All Household Pets eight (8) months of age or older must be spayed or neutered.

**Cages:** A single cage space 21" x 21" x 21" is provided with each entry. A double cage space is 21" x 21" x 45". Double size Sturdi type cages will require double cage space. You may purchase an additional space for \$20.00 per 21" wide. No more than one adult or two kittens per single cage space. **No grooming spaces can be placed in the aisles. Please bring your own cage. A limited supply of available wire cages must be pre-ordered with entry at \$10.00 per cage.**

**Check-In & Show Hours:** Check-in time will be 7:30 to 8:30 am Saturday. Show hours are from 9:00 am to 4:00 pm on Saturday and Sunday. Exhibitors and their cats must stay in the show hall during the advertised show hours unless they receive permission to leave from show management. PLEASE HELP US GET THE SHOW DONE BY 4:00 PM. One benching request per exhibitor will be honored whenever possible. No benching changes are permitted without the permission of the show manager.

**Food & Litter:** Litter will be provided. Cat food as donated. Please bring your cat's preferred food as well as dishes and litter pans. **No outside food or alcohol is allowed by this facility.** This includes no Grand Cakes or celebratory foods. **There are concessions in building next door.**

**Oregon Clean Air Act:** prohibits smoking, vaping, e-cigarettes, indoors or outdoors within 10 feet of public building entrances, exits, awnings or any covered areas. Please be respectful of these laws..
