**Entry Info:** Entry Fees include CFA & Regional surcharges. Entries accepted now. You are required to enter online <https://entries.cfa.org/onlineEntry.php> Check your confirmation for accuracy and contact the entry clerk with corrections **BEFORE THE CLOSING DATE. No substitutions after the closing date.** By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. **Payment Info:** Payment is required. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. **NO REFUNDS AFTER YOUR ENTRY HAS BEEN CONFIRMED OR FOR FAILURE TO ATTEND THE SHOW.** Make checks payable to Nashville Cat Club to our Entry Clerk or send a payment through PayPal to [nashvillecatclub@yahoo.com](mailto:nashvillecatclub@yahoo.com) Returned check fee is \$50 + all bank fees. *In order to expedite the check-in process we prefer exact cash.*

**Show Hall:** Expo 3 @ The Nashville Fairgrounds – Expo 3 401 Wingrove St. Nashville, TN 37203 Phone 615-662-8980. GPS address is 625 Smith Ave. Nashville, TN. People food will be available. This is a smoke-free facility. The facility has A/C and heat as needed. Free Parking. RV hookups are available; contact the fairgrounds for fees and more info.

**Show Hours:** Check-in 7:30-8:30 am; exhibitors of cats marked absent will need to check in with the clerk in each ring. Judging will start at 9 am Saturday and 8:30 am Sunday. Advertised show hours are 9 am – 4 pm (or end of finals) both days

**Benching:** Single cage size is approximate 22" x 22" x 22"; and is included with your entry. **Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage.** Clay litter will be provided. Please bring your own litter pans, cat food, and water/food dishes.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

**Household Pets:** All Household Pets over the age of 8 (eight) months must be neutered or spayed. HHPs may not be declawed.

**Show Rules:** CFA Show rules will be strictly enforced. Copy of rules may be obtained for \$7 from CFA, 260 E. Main St. Alliance, OH 44601. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.
