Show Hall: National Guard Armory, 151 Eggerts Crossing Rd., Lawrenceville, NJ 08648. Tel. 609-530-6906.: Entry Fees include CFA & Regional surcharges. Entries accepted now. You are required to enter online <https://entries.cfa.org/onlineEntry.php>. *HHP fee cannot be used as 1st or 2nd entry if you are also entering pedigreed cats. Please advise the entry clerk if this is your first show. Check your confirmation for accuracy and contact the entry clerk with corrections BEFORE THE CLOSING DATE. No substitutions after the closing date. By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7 each from CFA, 260 E. Main St. Alliance, OH 44601. Payment is required. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. NO REFUNDS AFTER YOUR ENTRY HAS BEEN CONFIRMED OR FOR FAILURE TO ATTEND THE SHOW. Make checks payable to Delaware River Cats. Returned Check fee is \$50 + bank fees. Zelle to drccnj@aol.com. Late Fee (for payments made after 3/1/26) \$75. **CASH ONLY AT CHECK-IN.**

Show Hours: Check in is 7:30 – 8:30 am, any cat not benched by 8:30 am will be marked absent and must check in with the clerk in each ring. Judging will start at 9 am. Advertised show hours are 9 am – 4 pm both days. All entries are asked to remain in hall until advertised closing time or until the end of finals.

Agility: Ring Master: Niki Feniak. *Single cage, does not include extra ½ cage space. **Agility Info:** <http://cfa.org/agility>

Scoring: All entries in Championship (except Novice), Premiership (except Novice), Agility (if offered), registered kittens, registered Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Benching: Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage; no single space at End of Row. Cages are approximately 22"x22"x22" and is included with your entry fees. Bring cage curtains (or coverings) to cover the sides, top and bottom of cage. Litter will be provided, but not litter pans.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia, feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition. No kittens under 4 months are permitted in the show hall.

Room Rate \$119 (includes pet fee, 2 cats max. per room), includes hot breakfast, free parking. Rooms have kitchenettes. Reservation cutoff is 1/7/26. Reservations after that date may not be available at the show rate. Any cancellation must be 24 hours in advance of check-in. There is no airport shuttle from the hotel. **Airport:** Philadelphia Intl. Airport (PHL) is approximately 45 miles/50 minutes from the show hall.
