Show Rules: The show will be conducted in accordance with current CFA show rules. These may be obtained online at <https://cfa.org/wp-content/uploads/2025/04/25-26show-rules.pdf> or send \$7.00 plus \$2.00 postage to CFA, 260 East Main Street, Alliance, OH 4460.

All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Rosettes and Ribbons will be awarded according to CFA show rules. No kitten under the age of four months will be allowed in the show hall. Blue slips may be required for proof of age.

Entries: Per CFA rules, only cats registered with either a permanent or temporary Registration number are eligible for entry in the Kitten, Championship and Premiership categories and the Veterans, Provisional Breed, Miscellaneous (Non-Competitive) or AOV Classes. All entries must be submitted via the main eCats CFA entry portal at <https://ecat.cfa.org>

Payment: Make checks or money orders payable in to "CFA Northwest Region" (U.S. funds only). Mail to: 3785 S. 2200 W. West Valley City, Utah 84119. Digital payment accepted via paypal – catfanNWregion@gmail.com CFA rules state that entry fees must be paid within 10 days after receiving entry confirmation. Since we cannot accept pay at the door, entry fees should be received electronically or by check no later than June 16, 2026. Late fee for payments received after June 20, 2026 = \$25.00. Returned check fee = \$40.00.

Health: This is a non-vetted show. Exhibitors are advised that all entries should be inoculated before entry by a licensed veterinarian against feline panleukopenia (formally known as feline distemper or feline infectious enteritis), rhinotracheitis, & calici viruses. Front and back claws must be clipped before Benching. Declawed cats are not eligible for entry. All cats are expected to be free of fleas, mites and infectious illness. Per show rules Show Management reserves the right to have any cat showing signs of illness, disease or parasites removed from the show hall in order to protect other cats in the show hall.

Household Pets: Household pets are eligible only for awards in the Household Pet Class. Household pets are to be judged separately from all other cats, solely on beauty and condition. Wild cats or wild cat-domestic hybrid crosses are not eligible for entry. All Household Pets eight (8) months of age or older must be spayed or neutered.

Cages: Bring your own security cage. A single Bench space of 22" x 24" is provided with each entry. A Groom space is 44" x 24". No more than one adult or two kittens per single bench space. No grooming tables can be placed in the aisles. Wire cages are available. Wire Cage Rental fee is 10.00 plus double cage fee, A limited number of popup cages can be purchased for \$35 each. Please reserve popups and/or wire cages in advance.

Recommended Airport: The Show Hall is 1 hour from the Portland, Oregon International Airport (PDX)

Check-In & Show Hours: Check-in time will be from 7:30-8:30 am

Judging starts at 9:00 a.m. sharp. Advertised Show hours are 9:00 am - 4:00 pm Exhibitors and their cats must stay in the show hall during advertised show hours unless they get permission from show management. One benching request per exhibitor will be honored whenever possible. No benching changes are permitted without the permission of the show manager. PLEASE HELP US GET THE SHOW DONE BY 4PM

Food & Litter: Litter will be provided. Please bring your cat's preferred food as well as dishes & litter pans. People food will be available for purchase in the show hall 10:00 a.m. to 2:00 p.m.
