Entry & Payment Info: Entries are accepted now. Entry Fees include CFA & Regional surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show (Cash only at door). Make checks payable to Seacoast Cat Club and send to entry clerk. Returned Check fee is \$50 plus all bank fees. PayPal accepted: payseacoastcat@yahoo.com **Please** No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench. **Check your confirmation for accuracy and contact the entry clerk with any corrections BEFORE THE CLOSING DATE.**

Show Hall: Everett Arena 15 Loudon Rd. Concord, NH 03301 603-228-2784. The show hall is handicapped accessible & climate controlled by industrial fans. People food available. **The Show Hall will be available for early benching set up on Friday between 3 - 4 pm. The show hall will be closed and locked at 4:30 Friday afternoon.**

Check In & Judging Info: Check-In: 8:30 – 9:30 am. Cats must be checked in by 9:30 am or they will be marked absent. Judging: 10 am Saturday; and at 9 am on Sunday.
Advertised Show Hours: 10 am – 5 pm Saturday and 9 am – 3 pm on Sunday. **Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a TRN. **Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed. **Benching:** Single cage size is approximately 22"x22"x22" and is included with your entry. Exhibitors with a single entry using a larger size security cage are required to purchase an extra 1/2 cage. **Sales Cage with paid entry only.** Please bring cage curtains, fabric or towels to cover the top, sides and back of cages. Litter will be provided. Food bowls, water bowls and litter pans will not be furnished.

First time exhibitors: Please check the NEW EXHIBITOR box on your entry form and visit <https://newexhibitor.cfa.org/>

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition. *The state of NH mandates current rabies inoculation for all cats in the show hall as well as current health certificates within ten days for cats/kittens being sold. It is advisable that you have your cat's certificates with you.*
