SHOW HALL: San Bernardino County Fairground (Victorville Fairground) 14800 7th Street, Victorville, CA 92395, Building 4. The show hall has both heat and AC as needed and is handicap accessible, with free parking adjacent to, and on the same level as, the show hall. No alcoholic beverages or smoking in or near the show hall allowed. Crown City Cat Club will not be responsible for damage, loss, personal injury, or loss of property.

CHECK-IN HOURS: 7:30 a.m. to 8:30 a.m. Saturday. Any entry not checked in by 8:30 a.m. will be marked absent. Judging will begin promptly at 9:00 a.m. on Saturday. Advertised show hours are from 10:00am to 5:00pm Saturday. All exhibitors are expected to be present during advertised show hours unless given permission to leave early by the show manager.

You must CHECK-IN when you first arrive to be counted present. Those who don't will be marked absent!

HEALTH: It is strongly advised that all cats or kittens present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition. All kittens must be four months of age on or before the first day of the show.

CFA SHOW RULES: will govern this show. A copy of the show rules can be purchased from CFA, Inc., 260 East Main St., Alliance, OH 44601 or found on the CFA website at cfa.org/wp-content/uploads/2022/03/22-23showrules.pdf. Rosettes will be awarded for all final wins. Permanent flats will be used, but ribbons will be available at the owner's request. The club reserves the right to add or change judges.

SCORING: All entries in Kittens, Championship, Premiership (except Novice), and Household Pets will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

BENCHING REQUESTS: will be limited to one exhibitor and will be honored when possible. No negative benching requests please. *End of row benching requests will be honored as available, with the fee waived for disabled exhibitors.

AMENITIES: Litter will be provided, but please bring your own litter pans. It is also suggested that you bring your own food and water bowls. Exhibitors with benching cages wider than 36" will need to purchase a groom space.

NEW EXHIBITORS: should bring a towel or rug for the floor of the cage and enough fabric to go around and cover the top of the cage. **ALL CATS MUST BE BROUGHT IN A CARRIER.** Declawed cats are not eligible for entry.

ENTRIES AND FEES: Make checks payable to CROWN CITY CAT CLUB and mailed to Brian Tripp at the address listed above. Bounced checks will incur a \$50 fee. Each entry must be submitted online. For entry clarification, the entry clerk will call collect. Entry fees must be received within 10 days of submitting an entry. **THE SHOW IS ACCEPTING ENTRIES NOW!**
